## Program Related Costs

- **Minnesota Teaching License related fees:**
  - **Initial/First Time Minnesota Educator License Application Fee:** \$90.25 which includes fingerprint card fee
  - **Renewal:** \$58.70 including Tax
- **Visa application processing fee to the United States Citizenship and Immigration Services (USCIS):** \$160
- **SEVIS fee:** \$220
- **Required Annual Insurance policy that meets the following minimum benefits [22 CFR 62.14]:**
  - ± \$60/month
    - Medical benefits of at least \$100,000 per accident or illness
    - Repatriation of remains in the amount of \$25,000
    - Expenses associated with the medical evacuation of the exchange visitor to his or her home country in the amount of \$50,000
    - A deductible not to exceed \$500 per accident or illness.

**Class D Driver's License:** \$18.50

## Expected Work Related Deductions

These are deductions you may see on your biweekly paycheck.

- **Teachers Retirement:** Approximately 7.5% of your paycheck. This contribution is refundable at the end of your service if you are unable to opt out.
- **Union Dues:**
- **Federal and State Tax:** 5.35% to 9.85%
- **Benefits (Health, Dental, Vision Insurance):** Dependent on package offered by employer. Please refer to information provided by your employer/Human resources department.
- **Federal Insurance Contributions Act (FICA) Taxes – [Social Security and Medicare Withholdings](#):** Exempt for 2 calendar years. Begins in your third year of service. The current tax rate for social security is 6.2% for the employer and 6.2% for the employee, or 12.4% total. The current rate for Medicare is 1.45% for the employer and 1.45% for the employee, or 2.9% total.

If there are deductions on your paycheck that you are unsure of, make sure to check with your Payroll department and then with your RO/ARO.
